

### DRYING TIME:

Dry hard: 4 hours

### THEORETICAL COVERAGE:

25-30 sq. m. / gal @ 40µm DFT

### SURFACE PREPARATION:

Adhesion barriers like dust, dirt, oil must be removed. Dry Surface thoroughly prior to painting.

**For smooth surfaces**, seal the surface using Epoxy FC 1805FC Sealer and let dry overnight. Sand with grit paper (#240 or #400) then apply Epoxy Primer and let dry overnight. Sand with grit paper (#400) then apply 2 coats of Industrial Sport Court Coating paint.

**For dented surfaces**, apply Epoxy Marine Putty after the sealer and let dry overnight. Sand with grit paper (#240) on applied Marine Putty and re-coat with Epoxy FC 1805FC Sealer and let dry overnight. Sand with grit paper (#240 or #400) then apply Epoxy Primer and let dry overnight. Sand with grit paper (#400) then apply 2 coats of Industrial Sport Court Coating paint.
