**ISLAND LIFE** is a low VOC (Volatile Organic Compound), low odor, anti-microbial water-based paint made from premium acrylic dispersion. This product contains an additive compound that helps reduce the growth of disease-causing bacteria like E. Coli, Staphylococcus Aureus & Pseudomonas Aeruginosa.

### USE:

Finish coat for interior walls and ceilings of hospitals, hotel rooms, bedrooms, classrooms, nursery rooms, elder care facilities, food processing plants and restaurants.

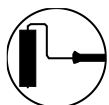
### FINISH:

Flat/Satin/Semi-gloss/Gloss

### APPLICATION:



Brush



Roller



Spray

### REDUCTION:

Use as is or may add ¼ - ½ liter clean water to a gallon of paint. For optimum performance, 2-3 coats are normally applied.

### DRYING TIME:

Dry to recoat; allow 2-4 hours

### COVERAGE:

Approximately 20-25 sq. m. / 4 liters

### SURFACE PREPARATION:

The surface must be dust-off, clean, free of dirt or any adhesion barrier. The surface must be thoroughly dry before painting.

### RECOMMENDED PRIMER:

Island Life Primer White

### PACKAGING:

4L plastic container

### SHELF LIFE:

3 years in unopened container

### STORAGE & DISPOSAL:

Keep container tightly sealed. Do not store above 35 °C. Must not be disposed together with household garbage. Do not allow product to reach sewage system. Disposal must be according to government regulations.
